Mushroom toxicosis alert from CDPH

ALERT:

Toxic mushroom *Amanita phalloides* causing human illnesses in California

The California Department of Public Health (CDPH) is alerting veterinarians to an **outbreak of amatoxin poisonings** linked to consumption of foraged toxic mushrooms (death cap mushrooms, *Amanita phalloides*). Between mid-November and December 9, 2025, there have been 23 human cases, primarily in the Monterey and San Francisco Bay Areas but risk is expected state-wide, particularly in areas adjacent to hardwoods (such as oaks) and also near some softwoods (such as pines).

Ingestion of *Amanita phalloides* **can be fatal to dogs**. CDPH encourages veterinarians to ask clients about wild mushroom consumption for patients that present with acute onset vomiting and diarrhea and live in, or have recently traveled to, areas where mushrooms are present.

If cases of mushroom toxicosis are suspected, amatoxin testing (mushroom, urine, or liver samples) is available for a fee at the **UC Davis California Animal Health and Food Safety Laboratory**. Additionally, urine and mushroom samples can be tested for free at the California Department of Public Health (Terri.Jackson@cdph.ca.gov).

Please address any questions about mushroom toxicosis in your area to your **local public health department**.

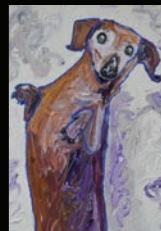
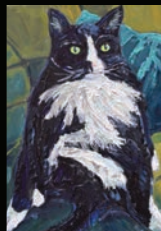
